

ORDINANCE NUMBER 06-2002 FOULING OF PROPERTY BY ANIMALS

THE VILLAGE OF MORLEY ORDAINS

ANIMAL EXCREMENT.

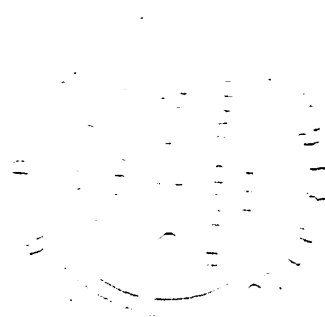
- (A) NO PERSON SHALL ALLOW ANY ANIMAL UNDER HIS/HER OWNERSHIP OR CONTROL TO LEAVE ITS EXCREMENT ON ANY PRIVATE OR PUBLIC PROPERTY UNLESS THAT EXCREMENT IS PROMPTLY AND THOROUGHLY REMOVED FROM THE PROPERTY. PROVIDED, HOWEVER, A PERSON MAY FAIL TO REMOVE THE EXCREMENT FROM PRIVATE PROPERTY WHICH THAT PERSON OWNS OR IN WHICH HE/SHE HAS A LAWFUL POSSESSORS INTERESTS
- (B) IT SHALL BE UNLAWFUL FOR ANY PERSON TO APPEAR WITH ANY ANIMAL ON ANY PRIVATE OR PUBLIC PROPERTY UNLESS THAT PERSON HAS THEN IN HIS/HER POSSESSION AN APPROPRIATE DEVICE FOR THE IMMEDIATE AND THROUGH REMOVAL OF ANY ANIMAL EXCREMENT. PROVIDED, HOWEVER, THE OWNER OR LAWFUL OCCUPANT OF A VACANT LOT, PARCEL OF REAL PROPERTY OR A PARCEL OF REAL PROPERTY ON WHICH THERE IS LOCATED A SINGLE FAMILY RESIDENCE, MAY APPEAR ON HIS OR HER PROPERTY WITH AN ANIMAL WITHOUT POSSESSING SUCH A DEVICE.
- (C) PENALTY.
- (1) A VIOLATION OF THIS ORDINANCE SHALL CONSTITUTE A MUNICIPAL CIVIL INFRACTION, WHICH, UPON AN ADMISSION OR FINDING OF RESPONSIBILITY, SHALL RESULT IN A FINE OF \$50 FIRST OFFENCE. SUBSEQUENCE VIOLATION SHALL BE \$ 75 AND THE NEXT \$ 1 00.

THIS ORDINANCE SHALL TAKE EFFECT THIRTY (30) DAYS AFTER PUBLICATION. ALL ORDINANCES OR PARTS OF ORDINANCES IN CONFLICT ARE HEREBY REPEALED.
